The Objective

The Conductor Global Equity Value ETF (the "ETF") seeks to provide long-term risk adjusted total return. The fund utilizes a process-focused strategy that seeks to produce long-term risk-adjusted returns for clients by investing in 40-100 global equities exhibiting superior fundamental attributes. The ETF incorporates a relative strength based technical analysis into the analytical process to complement the fundamental framework and enhance overall performance. Furthermore, Conductor Global purchases the international equities in the native foreign country and the native foreign currency providing an added layer of diversification: sector, geography, and currency.

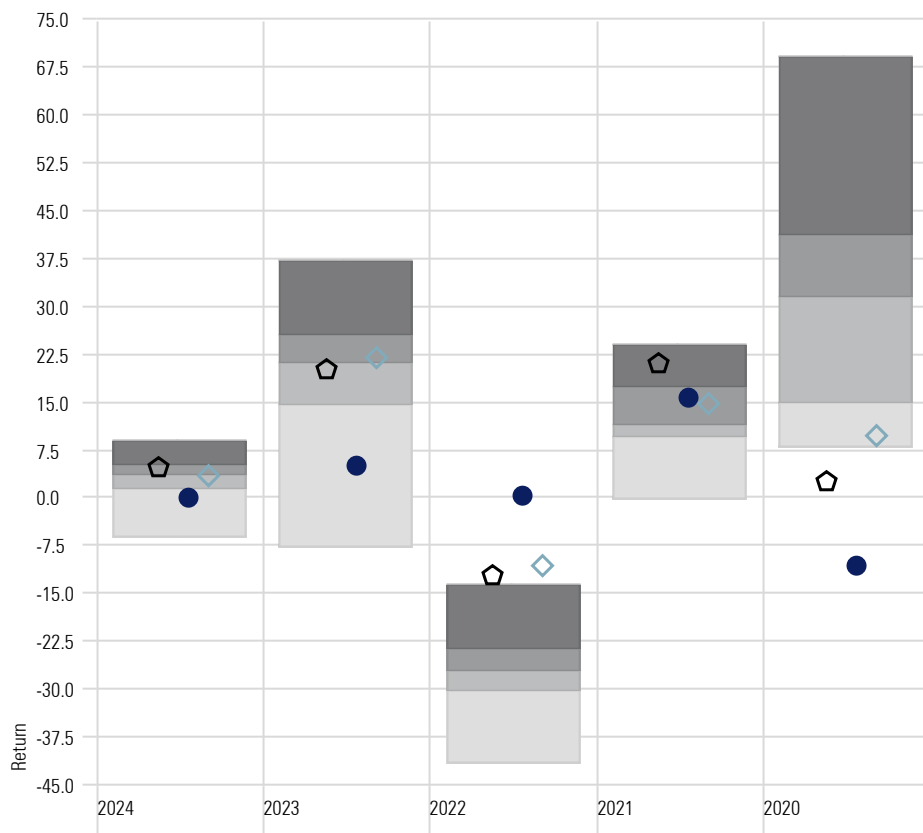
